- 3) Appointment of Krishnakumar Natarajan (DIN 00147772) as Executive Chairman – Ordinary Resolution

(ii) **Intimation of Record Date for the purpose of allotment of Bonus Equity Shares as per Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015:**

Please note that the Members of the Company have approved the issue of Bonus Shares in the proportion of 1 (One) Bonus Equity Share of Rs. 10/- (Rupees Ten only) each, for every 1 (One) fully paid-up Equity Share of Rs. 10/- (Rupees Ten only) each, held by the Members and that the Bonus Shares so distributed shall, for all purposes, be treated as an increase in the paid-up capital of the Company.

We further wish to inform that the Administrative Committee of the Board of Directors of the Company have approved and fixed March 10, 2016, Thursday, as the Record Date for the purpose of deciding the Members who shall be eligible to the allotment of the Bonus Shares as per the ratio mentioned above by capitalization of such sum as may be required, from the Securities Premium Account, Free Reserves or any other permitted reserves/ surplus of the Company for the purpose of issue of Bonus Shares of Rs. 10/- (Rupees Ten only) each, credited as fully paid-up to the holders of the Equity Shares of the Company, whose names appear on the Register of Members on the Record Date of March 10, 2016.

The fully paid-up Bonus Shares shall be distributed to the Members of the Company, whose names appear on the Register of Members as on March 10, 2016 of the Company. The Bonus Shares so allotted shall rank *pari-passu* in all respects with the fully paid-up Equity Shares of the Company as existing on March 10, 2016.
