Mindtree made an initial public offer and its shares were listed on stock exchanges in India on March 7, 2007. IPO price was ₹425 with a premium of ₹415 and there was no follow-on public offer as such in furtherance to this.

Bonus Issue

The company has made bonus issuance in the ratio of 1:1 each, in June 2014 and March 2016.
